
WHEREAS, the bid proposal of *R & L TRADING*, with the amount of *Php 891,256.00* was found to be substantially complying:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


