
WHEREAS, the bid proposal of **RD & R TRADING**, with the amount of **Php 361,834.00** was found to be substantially complying;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:




