AUTHORIZING MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO CONTRACT WITH GBL ENTERPRISES, MABINI, PORO, CEBU, FOR THE SUPPLY OF MATERIALS FOR SEWAGE TREATMENT FACILITY, SAN FRANCISCO, CEBU IN THE AMOUNT OF THREE HUNDRED THIRTY TWO THOUSAND SIX HUNDRED FORTY FOUR PESOS (P332,644.00) ONLY

WHEREAS, the Bids and Awards Committee of LGU San Francisco had conducted a public bidding for the **Supply of Materials for the Sewage Treatment Facility, San Francisco, Cebu** in the amount of **Three Hundred Thirty Two Thousand Six Hundred Forty Four Pesos (P332,644.00)** only;

Arquillano, Jr., to Enter into Contract with GBL ENTERPRISES, Mabini, Poro, Cebu, for the Supply of Materials for the Sewage Treatment Facility, San Francisco, Cebu** in the amount of **Three Hundred Thirty Two Thousand Six Hundred Forty Four Pesos (P332,644.00)** only.
