**RESOLUTION NO. 002-2020**

**WHEREAS**, brought to the attention of this Body for approval are the following Barangay Appropriation Ordinances, to wit:

1. Appropriation Ordinance No. 2019-009 of Barangay Consuelo, enacted under Resolution No. 027-SERIES 2019, realigning the amount of P25,000.00 from the 5% GAD allocated for the purchase of various materials for SNP Centers (Child and Youth Development), to TEV (Jeepney hiring during the Daycare and School Neighborhood Program SNP Culmination Program).
2. Appropriation Ordinance No. 2019-09 of Barangay Sta. Cruz, enacted under Resolution No.26-2019, realigning from the 5% GAD allocation for Training for Tanod and Lupon amounting P15,000.00, to Tanod Supplies of P15,000.00
3. Supplemental Budget No. 003-2019 of Barangay San Isidro, bearing Appropriation Ordinance No. 2019-006 enacted under Resolution No. 46-2019, involving an appropriation of P690,666.00
4. Supplemental Budget No. 02-2019 of Barangay Union, bearing Appropriation Ordinance No. 2019-04 enacted under Resolution No. 46-2019 involving an appropriation of P427,751.00
5. Supplemental Budget No. 02-2019 of Barangay Western Poblacion, bearing Appropriation Ordinance No. 2019-009 enacted under Resolution No. 65-2019, involving an appropriation or P276,493.70
