RESOLUTION NO. 007-2020

A RESOLUTION INTERPOSING NO OBJECTION TO THE PROPOSED ESTABLISHMENT OF **SUNRISE WATER REFILLING STATION** OWNED BY MR. DEMETRIO AKIATAN ORTIZ LOCATED AT PUROK LOWER BUNTOD, BARANGAY UNION, SAN FRANCISCO, CEBU

WHEREAS, **Mr. Demetrio Akiatan Ortiz**, manifested his intention of establishing a water refilling station, through Resolution No. 45-2019 of Barangay Union, Interposing no Objection to the proposed establishment of **Sunrise Water Refilling Station** to be located at Purok Lower Buntod, Barangay **Union**, of this Municipality;

WHEREAS, the said resolution was referred to the Committee on Infrastructure Chaired by Hon. Severino O. Gok-ong, Jr. for its consideration;

WHEREAS, after due consultation with the Barangay Captain of Union by the above mentioned committee, the proposed development is considerable for the reason and assurance of the applicant that the water to be used shall be bought from the Water Cooperative of Barangay Union;

WHEREAS, upon recommendation of the Committee on Infrastructure and considering that the proposed project may spur economic growth for the Barangay and the Municipality as well, the Sangguniang Bayan deemed it appropriate to respond favorably to the request of the applicant;

NOW THEREFORE, on motion of Hon. Severino O. Gok-ong, Jr., Chairman of the Committee in Infrastructure, duly seconded by Hon. Rey A. Tindoy, Chairman of the Committee on Ways and Means, and unanimously carried by all the Members of the Sangguniang Bayan presents and assembled, it is hereby,

RESOLVED to INTERPOSE NO OBJECTION to the proposed establishment and operation of **Sunrise Water Refilling Station** to be located at Purok Lower Buntod, Barangay **Union**, of this Municipality;
