AUTHORIZING THE HONORABLE MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO CONTRACTS WITH ALL THE SERVICE PROVIDERS OF THE 2020 TOWN FIESTA ACTIVITIES AND FOUNDING ANNIVERSARY

WHEREAS, the annual town fiesta and Founding Anniversary of San Francisco are celebrated with different activities and events like the "*Solisoli Festival*", *sports tournaments*, *Search for Miss San Francisco* and *such other amusement activities* wherein the local government unit has to hire competent persons that can provide all the needed services for the success of these activities;

WHEREAS, there shall be Contracts to be entered into by and between the municipality and the contractors for the services to be rendered, professional fees, and other incidental expenses due to them during the activities;

WHEREAS, as provided for in RA 7160, otherwise known as the Local Government Code of 1991, the municipal mayor can represent the municipality in all its business transactions and can sign documents relative thereto only upon authorization by the sanggunian concern;

Now, therefore, on motion of Hon. Severino O. Gok-ong, Jr., duly seconded by Hon. Francis N. Lucernas, and unanimously carried by all the Sangguniang Bayan Members of San Francisco, Cebu presents and assembled in session,

RESOLVED, to authorize the Honorable Municipal Mayor Alfredo A. Arquillano, Jr. to enter into Contracts with **all the service providers of the San Francisco Town Fiesta'2020 activities on March 18-19, and the Founding Anniversary on March 29;**
