RESOLUTION NO. 010-2020

CLARRIFYING FROM THE BUREAU OF IMMIGRATION THE CAUSES OF THE DELAY OF DEPORTATION OF AN UNDESIRABLE ALIEN NIKLAAS VONDELING, A DUTCH NATIONAL, AND REQUESTING THE SAID BUREAU THROUGH COMMISSIONER JAIME H. MORENTE TO IMMEDIATELY IMPOSE/EFFECT VONDELING'S DEPORTATION

WHEREAS, the Municipality of San Francisco had declared Niklaas Vondeling A.K.A. Nico as "**AN UNDESIRABLE ALIEN AND IS RECOMMENDED FOR DEPORTATION**", and "**AS PERSONA NON GRATA IN THE MUNICIPALITY OF SAN FRANCISCO, CEBU**" through Sangguniang Bayan Resolution No. 138-2014 and Resolution No. 179-2014, respectively;

WHEREAS, said Dutchman is considered inimical to public order, safety and morals not only by the Local Government Unit of San Francisco, Cebu and local residents, but also by other foreign nationals in San Francisco, failed to secure building permits for the two resorts that he was constructing in the municipality, and has pending criminal cases against him, one for grave oral defamation and another for slight oral defamation;

WHEREAS, Vondeling was apprehended on the strength of a warrant of deportation issued by the BI chief pursuant to a deportation order that the BI board of commissioners issued against him in September 2015;

WHEREAS, the then BI Intelligence Officer and FSU Chief Bobby Raquepo said in a post of the PNA dated April 9, 2018, Vondeling sought the reconsideration of the arrest order against him but the BI Board denied his plea, and on November 17, 2016, the BI Board of Commissioners passed a resolution affirming the deportation order against the Dutchman;

WHEREAS, another information on the same post of the PNA, is that the foreigner Vondeling Niklaas, identified by BI Commissioner Jaime Morente as an overstaying alien was arrested on April 4, 2018 at his home in Barangay Eastern Poblacion, Poro, Cebu by operatives from the Bureau's Fugitive Search Unit (FSU);

WHEREAS, this Body is wondering why Vondeling is still seen in the Municipality of San Francisco lately and is reportedly known he is in his residence in the Municipality of Poro, Cebu, and this Body also questions why the deportation has not yet effected.

Now, therefore, on motion of Hon. Severino O. Gok-ong, Jr., duly seconded in mass of all the Sangguniang Bayan Members of San Francisco, Cebu presents and assembled in session,

RESOLVED, to **CLARRIFY from the Bureau of Immigration the causes of the delay of deportation of an undesirable alien NIKLAAS VONDELING, a Dutch National, and requesting the said bureau to immediately impose/effect NIKLAAS VONDELING'S deportation;**

FINALLY, to send copies of this resolution to *Commissioner Jaime H. Morente, Bureau of Immigration, Office of the Commissioner, Room 208, Magallanes Drive, Intramuros 1002 Manila*, for his information and proper action.
