**RESOLUTION NO. 011-2020**

**AUTHORIZING MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) IN THE PURCHASE OF RICE IN CASE OF CALAMITIES OR FOR STOCK PILING IN PREPARATION FOR UNWANTED EVENTUALITIES UNDER THE "RICE SALES PROGRAM" OF THE NFA**

**WHEREAS**, the NFA is implementing the "Rice Sales Program" wherein LGUs shall be allowed to purchase rice from NFA either in cash or on credit in case of calamities or for stock piling in preparation for unwanted eventualities;

**WHEREAS**, there shall be a MOA to be executed between the NFA and the LGU stipulated therein the payment policy, volume of purchase, obligations of both parties, and other conditions stated in the proforma MOA, that was read and agreed by this August Body;

Now, therefore, on motion of *Hon. Severino O. Gok-ong, Jr.*, duly seconded by *Hon. Nerisa L. Arquillano*, and carried unanimously by all the Members of the Sangguniang Bayan of San Francisco, Cebu, presents and assembled in session,

RESOLVED, that this Sangguniang Bayan hereby **AUTHORIZES Municipal Mayor Alfredo A. Arquillano, Jr.** to enter into a **MOA with NFA in the purchase of rice under the NFA "Rice Sales Program"**.
