AUTHORIZING MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH (DOH) REPRESENTED BY DR. JAIME S. BERNADAS, IN HIS CAPACITY AS THE DIRECTOR OF THE REGIONAL OFFICE VII – CENTRAL VISAYAS, IN THE IMPLEMENTATION OF THE DOCTORS TO THE BARRIOS (DTTB) PROGRAM

WHEREAS, the Municipality of San Francisco, Cebu had requested the DOH to avail the DTTB Program considering of its lack of doctors to address the health problems of the constituents;

WHEREAS, the DOH considers LGU San Francisco eligible to avail the DTTB Program thus, assigned **Dr. Johnleh M. Surio** in the municipality as part of the DOH – DTTB Program;

WHEREAS, there shall be a MOA to be entered into by and between the Municipality of San Francisco and the DOH Regional Office VII in the implementation of the DTTB Program stipulating therein the responsibilities of both parties, the Provincial Health Office, DOH Central Office, the DTTB and such other conditions in the proforma MOA.

Now, therefore, on motion of *Hon. Rey A. Tindoy, Chairman of the Committee on Health and Sanitation duly seconded by Hon. Nerisa L. Arquillano, and carried unanimously by all the Members of the Sangguniang Bayan of San Francisco, Cebu*, presents and assembled in session,

RESOLVED, that this Sangguniang Bayan hereby **AUTHORIZES Municipal Mayor Alfredo A. Arquillano, Jr.** to enter into a **MOA** with the **(DOH)** represented by **Dr. Jaime S. Bernadas**, in his capacity as the **Director of the Regional Office VII – Central Visayas**, in the implementation of the **DTTB Program**.
