**WHEREAS**, brought to the attention of this Body for approval are the following Barangay Appropriation Ordinances, to wit:

- a) Appropriation Ordinance No. 2019-003 of Barangay Unidos, enacted under Resolution No. 021 A-2019, the Barangay Annual Budget for CY 2020 involving an appropriation of Two Million Two Hundred Thousand Pesos (P2,200,000.00) only.
- b) Appropriation Ordinance No. 2019-09 of Barangay Southern Poblacion, enacted under Resolution No. 42-2019, the Barangay Annual Budget for CY 2020 involving an appropriation of Four Million Five Hundred Twenty Eight Thousand Pesos (P4,528,000.00) only.
- c) Supplemental Budget No. 004-2019 bearing Appropriation Ordinance No. 2019-007 of Barangay San Isidro, enacted under Resolution No. 47-2019, involving an appropriation of Two Hundred Thirty Eight Thousand Six Hundred Four Pesos (P238,604.00) only.
