**RESOLUTION NO. 018-2020**

**FAVORABLY ENDORSING TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) THROUGH PAMB-CIMSFER THE GRANTING OF AN ENVIRONMENTAL COMPLIANCE CERTIFICATE (ECC) FOR THE CAMOTES TOURIST INN LOCATED AT UPPER MANGODLONG, BARANGAY HIMENSULAN, SAN FRANCISCO, CEBU**

WHEREAS, a representative of Camotes Tourist Inn, a development located at Upper Mangodlong, Barangay Himensulan, San Francisco, Cebu is requesting from this August Body for a viability clearance and endorsement to the DENR through PAMB-CIMSFER for the issuance of ECC for the said development project, wherein, the same had already been given acceptability clearance by the Barangay concerned through a resolution after a public hearing being conducted;

WHEREAS, as said proposed development had been socially accepted by the barangay concerned considering that it does not pose hazard to the nearby residents, and that the same can provide jobs to the constituents, thereby, this body unanimously approves;

Now, therefore, on motion of Hon. Severino O. Gok-ong, Jr., duly seconded by Hon. Nerisa L. Arquillano and carried unanimously by the Members of the Sangguniang Bayan of San Francisco, Cebu presents and assembled,

RESOLVED, to grant a viability clearance and favorable endorsement to the DENR, Region VII through PAMB-CIMSFER, the issuance of ECC for the **Camotes Tourist Inn, a development located at Upper Mangodlong, Barangay Himensulan, San Francisco, Cebu**, applied for an issuance of ECC provided that:

1. The project's/development's sewage, stormwater and wastewater treatment facility must be constructed before its operation, and must be discharged in a manner complying with Chapter XVII – "Sewage Collection and Disposal, Excreta Disposal and Drainage" of the Code on Sanitation of the Philippines (PD 856) and its implementing rules and regulations (5.3 of the IRR of PD 856 - Sewage Disposal and Drainage).
2. The developer must strictly observe and obey the provisions of **MUNICIPAL ORDINANCE NO. 2009-061, THE MODIFIED ORDINANCE OF INTEGRATED AND ECOLOGICAL SOLID WASTE MANAGEMENT OF THE MUNICIPALITY OF SAN FRANCISCO, CEBU**
3. The applicant must follow all laws and rules of the national government and the local government units concerned in the implementation of said development project for violation of such, the LGU may exercise the mandate pursuant to RA 7160 to seek relief from the competent court for the removal of these structures/developments.

FINALLY, to release a copy of this resolution to the applicants, **the owners of Camotes Tourist Inn, a development located at Upper Mangodlong, Barangay Himensulan, San Francisco, Cebu** for information and guidance, and to the DENR Region VII for information and appropriate action.
