**RESOLUTION NO. 020-2020**

**A RESOLUTION REQUESTING THE HONORABLE CEBU PROVINCIAL GOVERNOR GWENDOLYN F. GARCIA TO GRANT FINANCIAL ASSISTANCE OF FOUR MILLION PESOS (P4,000,000.00) INTENDED FOR THE IMPROVEMENT OF PUBLIC TOILETS IN THE SAN FRANCISCO PUBLIC MARKET, IN THE MUNICIPAL GYMNASIUM, IN BAYWALK, AND IN LAKE DANAOPARK**

WHEREAS, improving or building hygienic public toilets is one of the best ways of revitalizing a local government unit for the reason that those hygienic public toilets are one of the vital requirements of a healthy population, and a fundamental human right;

WHEREAS, provision of public toilets is a way of promoting social inclusion and equality, and it is an issue of privacy and basic human decency;

WHEREAS, it is deemed necessary by this August Body to provide facilities and services that anybody would want to use voluntarily for the safe disposal of human urine and fecal matters.

WHEREAS, lack of proper sanitation is a serious issue that is affecting most places in the country and the importance of hygienic toilets prevent diseases which can be transmitted through human waste.

Now, therefore, on motion of Hon. Allen A. Arquillano duly seconded by Hon. Francis N. Lucernas and unanimously carried by all the Sangguniang Bayan Members of San Francisco, Cebu, presents and assembled in session,

RESOLVED, to request the **Honorable Cebu Provincial Governor Gwendolyn F. Garcia** to cause to allocate the amount of Four Million Pesos (P4,000,000.00) to be used for **the improvement of public toilets in the San Francisco Public Market, in the Municipal Gymnasium, in baywalk, and in Lake Danao Park;**

FINALLY, that a copy of this resolution be furnished to the **Honorable Cebu Provincial Governor Gwendolyn F. Garcia**, Cebu Capitol, Cebu City for her information and favorable approval.
