RESOLUTION NO. 021-2020

A RESOLUTION AUTHORIZING MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH (DOH) CENTRAL VISAYAS CENTER FOR HEALTH DEVELOPMENT – SUBNATIONAL BLOOD CENTER FOR VISAYAS, REPRESENTED BY JAIME S. BERNADAS, MD, MGM, CESO III, DIRECTOR IV, DEPARTMENT OF HEALTH, CENTRAL VISAYAS CENTER FOR HEALTH DEVELOPMENT IN THE IMPLEMENTATION OF THE NATIONAL VOLUNTARY BLOOD SERVICES PROGRAM (NVBSP)

WHEREAS, Republic Act No. 7719, also known as the **National Blood Services Act of 1994**, promotes **voluntary blood donation** to provide sufficient supply of safe **blood** and to regulate **blood** banks, and aims to inculcate public awareness that **blood donation** is a humanitarian act;

WHEREAS, the DOH intensifies its advocacy on voluntary blood donation to provide and allocate safe blood supply, sustaining its adequacy, affordability, equitable distribution and ensuring accessibility to the needing public;

WHEREAS, the LGU is the implementing unit of all DOH programs including the NVBSP, and there shall be a MOA to be entered into by and between the **Municipality of San Francisco** and the **DOH Central Visayas Center for Health Development – Subnational Blood Center for Visayas** to attain the goals of the strategic plan for 2016-2022 of the NVBSP.

Now, therefore, on motion of Hon. Rey A. Tindoy, Chairman of the Committee on Health, duly seconded by Hon. Allen A. Arquillano and unanimously carried by all the Sangguniang Bayan Members of San Francisco, Cebu, presents and assembled in session,

RESOLVED, to **authorize** Municipal Mayor Alfredo A. Arquillano, Jr. to enter into a MOA with the DOH Central Visayas Center for Health Development – Subnational Blood Center for Visayas, represented by Jaime S. Bernadas, MD, MGM, CESO III, Director IV, Department of Health, Central Visayas Center for Health Development in the implementation of the **NATIONAL VOLUNTARY BLOOD SERVICES PROGRAM (NVBSP)**;
