RESOLUTION NO. 028 -2020

AUTHORIZING THE HONORABLE MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO CONTRACT WITH YES CONSTRUCTION IN THE SUPPLY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF MULTI-PURPOSE BUILDING IN BARANGAY NORTHERN POBLACION

WHEREAS, the Bids and Awards Committee of LGU San Francisco had conducted a public bidding for the **Supply of Labor and Materials for the Construction of Multi-Purpose Building at Barangay Northern Poblacion, San Francisco, Cebu** in the amount of **Two Million Nine Hundred Ninety Seven Thousand Three Hundred Eighty Five Pesos (P2,997,385.00)** only;

Arquillano, Jr., to **enter into contract with YES CONSTRUCTION, Room 203, Cebu Long Se Temple, Osmeña Blvd., Cebu City in the Supply of Labor and Materials for the Construction of Multi-Purpose Building in Barangay Northern Poblacion in the amount of Two Million Nine Hundred Ninety Seven Thousand Three Hundred Eighty Five Pesos (P2,997,385.00)** only;
