**RESOLUTION NO. 029 -2020**

**AUTHORIZING THE HONORABLE MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO CONTRACT WITH SEV'S FOOD AND CATERING SERVICES IN THE SUPPLY OF MEALS AND SNACKS FOR SAKODO MEETINGS, TRAINING AND SEMINARS, MEALS AND SNACKS DURING CONSULTATIVE MEETINGS, VISITORS FROM CEBU PROVINCE, NATIONAL AGENCIES AND OTHER VISITORS, AND ACTIVITIES**

WHEREAS, the Bids and Awards Committee of LGU San Francisco had conducted a public bidding for the **Supply of Meals and Snacks for SAKODO Meetings, Training and Seminars, Meals and Snacks During Consultative Meetings, visitors from Cebu Province, national agencies and other visitors, and activities** in the amount of **Two Hundred Sixty Six Thousand Two Hundred Ten Pesos (P266,210.00)** only;
