- Supplemental Budget No. 03-2019 of Barangay Western Poblacion bearing Appropriation Ordinance No. 2019-011 enacted under Resolution No. 073-2019 involving an appropriation of P73,155.00
- Appropriation Ordinance No. 11-2019 of Barangay Santa Cruz enacted under Resolution No. 28-2019, realigning the amount of P20,000.00 financial counterpart continuing 2018, to Street Lighting Maintenance of P20,000.00
- Appropriation Ordinance No. 12-2019 of Barangay Santa Cruz enacted under Resolution No. 29-2019, realigning the amount of P50,000.00 intended for the purchase of steel matting for the Brgy. Gym continuing 2018, to Public Market Repair of P50,000.00
