RESOLUTION NO. 033-2020

A RESOLUTION AUTHORIZING MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE (DA), REGIONAL FIELD OFFICE NO. 7 IN THE IMPLEMENTATION OF THE HIGH VALUE CROPS DEVELOPMENT PROGRAM (HVCDP)

WHEREAS, the DA Field Office 7 is implementing the HVDP aiming to increase production of major high value crops and other economically important crops to improve farm income and increase the supply of these commodities in the domestic market;

WHEREAS, the project of DA RFO 7 under the HVDP is the procurement of one (1) unit MULTICULTIVATOR amounting Two Hundred Twenty Eight Thousand Pesos (P228,000.00) allocated per GA FY-2020;

WHEREAS, the LGU is in dire need of this project to expand agricultural development to allow marginal farmers to improve their local food production, and the former assures that it is capable to operate, manage and maintain the project.

Now, therefore, on motion of Hon. Severino O. Gok-ong, Jr., duly seconded by Hon. Israel B. Garrido and unanimously carried by all the Sangguniang Bayan Members of San Francisco, Cebu, presents and assembled in session,

RESOLVED, to **authorize** Municipal Mayor Alfredo A. Arquillano, Jr. to enter into a MOA with the **Department of Agriculture (DA), Regional Field Office No. 7** in the implementation of the **High Value Crops Development Program (HVCDP)** through its project procurement of one (1) unit **MULTICULTIVATOR**;
