RESOLUTION NO. 034-2020

A RESOLUTION AUTHORIZING MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REGIONAL FIELD OFFICE NO. VII, IN THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM

WHEREAS, the State in its endeavor to address malnutrition among children enacted RA No. 11037, otherwise known as the "*Masustansyang Pagkain para sa Batang Pilipino Act of 2018*", which also mandates the institutionalization of a Comprehensive National Feeding Program for undernourished children in public Daycare, Kindergarten, and Elementary Schools noting the confirmed link between food and nutrition and the capacity of children to develop and learn, including the supplemental feeding program in daycare centers or in any other facility used for such purposes;

WHEREAS, based is the data from the 8th National Nutrition Survey (2013) conducted by the Nutrition Research Institute of the Department of Science and Technology with updates as of 2015 revealed that the prevalence of under and over nutrition among Filipino children significantly increased compared to its 2008 survey;

WHEREAS, the DSWD in coordination with the LGU will be implementing the Supplementary Feeding Program to targeted children of at least one (1) fortified meal for a period of not less than One Hundred Twenty days in a year.

Now, therefore, on motion of Hon. Allen A. Arquillano, duly seconded by Hon. Nerisa L. Arquillano and unanimously carried by all the Sangguniang Bayan Members of San Francisco, Cebu, presents and assembled in session,

RESOLVED, to **authorize** Municipal Mayor Alfredo A. Arquillano, Jr. to enter into a MOU with the **DSWD, Regional Field Office No. 7** in the implementation of the **Supplementary Feeding Program** in the Municipality of San Francisco to targeted children of at least one (1) fortified meal for a period of not less than One Hundred Twenty days in a year as the DSWD's contribution to the Early Childhood Care and Development (ECCD) Program of the government;

FINALLY, that a copy of this resolution be furnished to the DSWD, Regional Field Office No. VII, with office address at DSWD Field Office VII, M. J. Cuenco Avenue Corner Gen. Maxilom Avenue, Brgy. Carreta, Cebu City represented by its Regional Director, Rebecca P. Geamala in the implementation of the Supplementary Feeding Program, for her information.
