A RESOLUTION ADOPTING MEMORANDUM CIRCULAR NO. 11, SERIES OF 2019 OF THE DSWD, THE REVISED GUIDELINES ON THE IMPLEMENTATION OF ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS)

WHEREAS, it is one of the thrusts of the government to contribute to better and improved quality of life for the citizenry giving priority attention to the poor, vulnerable and marginalized sectors of the society thus, through the Department of Social Welfare and Development (DSWD), it implements social welfare, social protection and anti-poverty programs, projects and services such as the Assistance to Individuals in Crisis Situation (AICS);

WHEREAS, the DSWD issued Memorandum Circular No. 11, Series of 2019, the "*Revised Guidelines on the Implementation of Assistance to Individuals in Crisis Situation (AICS)*", so that the vulnerable and marginalized individuals and families needing immediate intervention may have access to basic services;
