RESOLUTION NO. 040-2020

ENACTING APPROPRIATION ORDINANCE NO. 2020-03, AN ORDINANCE REALIGNING FROM THE 2015-2018 UNEXPENDED LDRRM FUND ALLOCATION FOR THE RETROFITTING OF MDRRMO EMERGENCY OPERATION CENTER AMOUNTING ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00), TO PURCHASE OF FURNITURE AND FIXTURES AND REPAIR OF COMFORT ROOM OF THE MDRRMO, AND REALIGNING FROM THE ALLOCATION OF THE PEACE AND ORDER AND PUBLIC SAFETY PARTICULARLY THE MEAL ALLOWANCE FOR SECURITY SUPPORT DURING THE SOLI-SOLI FESTIVAL OF SIXTY THOUSAND PESOS (P60,000.00) AND THE INFORMATION DESSIMINATION ON LAWS INVOLVING WOMEN DURING THE WOMEN'S MONTH CELEBRATION OF TWENTY FIVE THOUSAND PESOS (P25,000.00), FOR A TOTAL OF EIGHTY FIVE THOUSAND PESOS (P85,000.00), TO CAFGU FOOD SUPPORT

WHEREAS, CAFGU has newly been established in the Municipality of San Francisco and it has been seen by this LGU to provide support particularly food support during the time of duty and operations;

WHEREAS, there is a need to realign funds from unused allocations in the Peace and Order and Public Safety Budget intended for the above-mentioned purpose;

Now, therefore, on motion of Hon. Rey A. Tindoy, Chairman of the Committee on Budget and Appropriations duly seconded by Hon. Alan R. Arrojado, Chairman of the Committee on Peace and Order and Public Safety, and carried unanimously by the Members of the Sangguniang Bayan presents and assembled in session,

RESOLVED, to enact **Appropriation Ordinance No. 2020-03**, to wit:

APPROPRIATION ORDINANCE NO. 2020-03

AN ORDINANCE REALIGNING FROM THE 2015-2018 UNEXPENDED LDRRM FUND ALLOCATION FOR THE RETROFITTING OF MDRRMO EMERGENCY OPERATION CENTER AMOUNTING ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00), TO PURCHASE OF FURNITURE AND FIXTURES AND REPAIR OF COMFORT ROOM OF THE MDRRMO, AND REALIGNING FROM THE ALLOCATION OF THE PEACE AND ORDER AND PUBLIC SAFETY PARTICULARLY THE MEAL ALLOWANCE FOR SECURITY SUPPORT DURING THE SOLI-SOLI FESTIVAL OF SIXTY THOUSAND PESOS (P60,000.00) AND THE INFORMATION DESSIMINATION ON LAWS INVOLVING WOMEN DURING THE WOMEN'S MONTH CELEBRATION OF TWENTY FIVE THOUSAND PESOS (P25,000.00), FOR A TOTAL OF EIGHTY FIVE THOUSAND PESOS (P85,000.00), TO CAFGU FOOD SUPPORT

Be it ordained by the Sangguniang Bayan of San Francisco, Cebu, that:

SECTION 1. – There shall be realigned from the 2015-2018 unexpended LDRRM Fund allocation for the retrofitting of MDRRMO Emergency Operation Center amounting One Million Five Hundred Thousand Pesos (P1,500,000.00), to purchase of furniture and fixtures and repair of comfort room of the MDRRMO, and from the allocation of the Peace and Order and Public Safety Fund particularly the meal allowance for security support during the Soli-Soli Festival of Sixty Thousand Pesos (P60,000.00) and the information dissemination on laws involving women during the Women's Month Celebration of Twenty Five Thousand Pesos (P25,000.00), for a total of Eighty Five Thousand Pesos (P85,000.00), to CAFGU Food Support;

SECTION 2. – This Appropriation Ordinance shall take effect upon approval.
