**RESOLUTION NO. 045-2020**

**AUTHORIZING MUNICIPAL MAYOR ALFREDO A. ARQUILLANO, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DepEd) – DIVISION OF CEBU WITH OFFICE ADDRESS AT IPHO BUILDING, SUDLON, LAHUG, CEBU CITY, PHILIPPINES, REPRESENTED BY ITS SCHOOL DIVISIONS SUPERINTENDENT, MARILYN S. ANDALES, ED.D., CESO V, IN DESIGNATING DepEd ELEMENTARY AND HIGH SCHOOL BUILDINGS AND FACILITIES AS TEMPORARY MUNICIPAL CENTERS FOR SPECIAL CARE FOR COVID-19 PERSONS UNDER MONITORING (PUM)**

WHEREAS, Section 447 (a) (1) (iv) of RA 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan shall enact ordinances and approve resolutions to adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, because of COVID-19 declared “PANDEMIC” by the World Health Organization (WHO) due to the climbing number of COVID-19 cases, deaths, and affected countries getting higher in just days and weeks affecting many countries in the world including the Philippines, and the alarming levels of spread and severity, there is a need to adopt measures to fight this calamity;

Now, therefore, on motion of Hon. Rey A. Tindoy duly seconded by Hon. Israel B. Garrido and carried unanimously by the Members of the Sangguniang Bayan of San Francisco, Cebu presents and assembled,

RESOLVED, to **authorize** Municipal Mayor Alfredo A. Arquillano, Jr. to enter into a **MOA** with the DepEd in designating and using DepEd Elementary and High School Buildings and Facilities in the District of San Francisco, as temporary Municipal Centers for Special Care for COVID-19 Persons under Monitoring (PUM).
