RESOLUTION NO. 047-2020

ENACTING APPROPRIATION ORDINANCE NO. 2020-04, AN ORDINANCE REALIGNING THE AMOUNT OF TWENTY FIVE THOUSAND PESOS (P25,000.00) FROM THE TWO HUNDRED FIFTY THREE THOUSAND FIVE HUNDRED TWENTY THREE PESOS (P253,523.00) ALLOCATION FOR YOUNG AT HEART PROGRAM UNDER THE RHU SENIOR/CITIZENS PROGRAM ACCOUNT, TO CENTENARIAN CASH INCENTIVE

WHEREAS, SEC. 447 (a) (5) (xvii) of RA 7160, otherwise known as the Local Government Code of 1991 provides that the sangguniang bayan shall approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this Code, and in addition to said services and facilities, shall: Establish a municipal council for the elderly which shall formulate policies and adopt measures mutually beneficial to the elderly and to the community; provide incentives for non-governmental agencies and entities and, subject to the availability of funds, appropriate funds to support programs and projects for the benefit of the elderly;

Now, therefore, on motion of Hon. Rey A. Tindoy, Chairman of the Committee on Budget and Appropriations duly seconded by Hon. Ruben O. Raña, Chairman of the Committee on Senior Citizens Affairs, and carried unanimously by the Members of the Sangguniang Bayan presents and assembled in session,

RESOLVED, to enact **Appropriation Ordinance No. 2020-04**, to wit:

AN ORDINANCE REALIGNING THE AMOUNT OF TWENTY FIVE THOUSAND PESOS (P25,000.00) FROM THE TWO HUNDRED FIFTY THREE THOUSAND FIVE HUNDRED TWENTY THREE PESOS (P253,523.00) ALLOCATION FOR YOUNG AT HEART PROGRAM UNDER THE RHU SENIOR/CITIZENS PROGRAM ACCOUNT, TO CENTENARIAN CASH INCENTIVE

Be it ordained by the Sangguniang Bayan of San Francisco, Cebu, that:

SECTION 1. – There shall be realigned from the **Two Hundred Fifty Three Thousand Five Hundred Twenty Three Pesos (P253,523.00)** allocation for the **YOUNG AT HEART PROGRAM** under the **RHU Senior/Citizens Program Account**, the amount of **Twenty Five Thousand Pesos (P25,000.00)**, to **Centenarian Cash Incentive**;

SECTION 2. – This Appropriation Ordinance shall take effect upon approval.
