RESOLUTION NO. 050-2020

ENACTING APPROPRIATION ORDINANCE NO. 2020-05, AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION SIX HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED SIXTY SEVEN PESOS (P2,618,767.00) FROM THE SOCIO-CULTURAL ALLOCATIONS CY 2020, TO GENERAL SERVICES OF THE MAYOR'S OFFICE AMOUNTING TWO MILLION SIX HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED SIXTY SEVEN PESOS (P2,618,767.00)

WHEREAS, SEC. 447 (a) (1) : (viii) of RA 7160, otherwise known as the Local Government Code of 1991 provides that the sangguniang bayan shall approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this Code, and in addition to said services and facilities, shall: Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;;

Now, therefore, on motion of Hon. Rey A. Tindoy, Chairman of the Committee on Budget and Appropriations duly seconded by Hon. Francis N. Lucernas, and carried unanimously by the Members of the Sangguniang Bayan presents and assembled in session,

RESOLVED, to enact **Appropriation Ordinance No. 2020-05**, to wit:

APPROPRIATION ORDINANCE NO. 2020-05

AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION SIX HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED SIXTY SEVEN PESOS (P2,618,767.00) FROM THE SOCIO-CULTURAL ALLOCATIONS CY 2020, TO GENERAL SERVICES OF THE MAYOR'S OFFICE AMOUNTING TWO MILLION SIX HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED SIXTY SEVEN PESOS (P2,618,767.00)

Be it ordained by the Sangguniang Bayan of San Francisco, Cebu, that:

SECTION 1. – There shall be realigned the amount of **Two Million Six Hundred Eighteen Thousand Seven Hundred Sixty Seven Pesos (P2,618,767.00)** from the **Socio-Cultural Allocations CY 2020 (Two Million Sixty One Thousand Pesos (P2,061,000.00) intended for Soli-soli Festival, and Five Hundred Fifty Six Thousand Nine Hundred Twenty Two Pesos (P556,992.00) intended for Founding /Fiesta)**, to **General Services of the Mayor's Office amounting Two Million Six Hundred Eighteen Thousand Seven Hundred Sixty Seven Pesos (P2,618,767.00)**, to wit:

SECTION 2. – This Appropriation Ordinance shall take effect upon approval.
