In three (3) separate sealed envelopes, the first containing the technical companent of the bid with the name of increast and the second containing the financial component of the bid with the name of the bidder in capital letters, addressed to the BAC. Bidders shall mark two envelopes; "DO NOT OPEN BEFORE (date, and and opening of bids.)." Both envelopes shall then be sealed in an outer envelope, which shall be addressed to the BAC and shall be marked as sealed.

8 ds submitted after the deadline on October 12, 2022, at 2:00 PM, shall not be accepted.

Bidders may modify their pies, provided that this is done before the deadline for the submission and receipt of hids. A bidder who modifies its bid shall not be allowed to retrieve its original, but shall only be allowed to send another bid equally sealed, properly identified, linked to its original bid and marked as a "Modification" thereof, and stamped "received" by the BAC.
