CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of _____ between **Municipality of San Francisco, Cebu** represented by **ALFREDO A. ARQUILLANO JR.**—Municipal Mayor, with office address at Poblacion, San Francisco, Cebu and **VSP STRUCTURE VENTURES CORP. (FORMERLY: VIRLO CONSTRUCTION)**, represented by **VIRGILIO B. PONGASE**—Authorized Managing Officer, with office address at Pilipog, Cordova Cebu.

WHEREAS, the Entity is desirous that the Contractor execute **To Supply Labor and Materials, Equipment including Minor Tools used for Construction of a Sanitary Landfill (phase II) SLF-CELL-LANDFILL Liner System Bottom-Layer at Himangkongan, Him San Francisco, Cebu - 2023-09-0485** (hereinafter called "the Works") and the Entity has accepted the Bid for **Eight Million Nine Hundred Ninety-Five Thousand Six Hundred Four Pesos and 45/100 (Php 8,995,604.45)** by the Contractor for the execution and completion of such Works a time duration of **Sixty-One (61) Working Days** and the remedying of any defects therein.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
