
WHEREAS, the bid proposal of *K-IT TECHNOLOGY TRADING*, with the amount of *Php 447,130.00* was found to be substantially complying;


- To recommend for approval by Municipal Mayor Alfredo A. Arquillano Jr. the foregoing findings.
